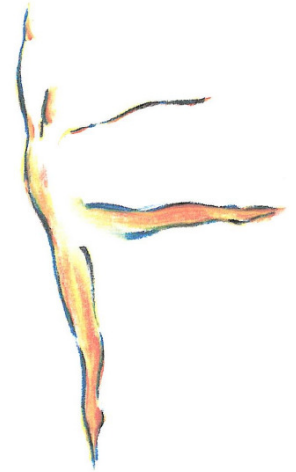

**Please read and note all terms and conditions of enrolment stated below before signing and dating and keep a copy for your attention.**

2. The DANCE CO. will not be held responsible for any losses that may occur on the premises.
3. All fees are payable TERMLY in advance and are due within 10days of term. Credit control on all accounts will be strictly enforced and no account may be paid later than the 10<sup>th</sup> of the month / or term. A 10% surcharge will be added to the unpaid balance if the account is not paid by the due date. These conditions must be adhered to, failing which you will be requested to call the studio and explain your position. All fees to be paid before an exam, festival, demonstration, championship, Eisteddfods, etc., is participated in.
4. No classes will be held on public holidays unless specified.
5. Management reserves the right to distribute and use funds as they seem fit.
6. No classes will be made up if cancelled due to teacher's illness.
7. Due to the distraction caused, no parents will be permitted to watch classes. No exceptions will be made.
